Overview

During the month of June 2011, we experienced a slight increase in our overall traffic crashes when compared to the month of May 2011. Northern Command officers handled 241 crashes in the month of June. An overview of the crashes showed 168 were property damage, 66 were injury, and seven were fatal. When compared to June of last year, fatal crashes increased by one accident. As compared to June of 2010, our regional commercial vehicle crashes increased from 11, to 21 crashes. In our overall June 2011 totals, intoxicated drivers were responsible for 20 of our total crashes in the Northern Command.

The officers in our command arrested 112 intoxicated drivers this month. The average blood alcohol level of these intoxicated drivers was, .18%, almost twice the legal limit of .08% blood alcohol content. The average age of the intoxicated drivers was 37 years old. Our officers arrested an additional 89 people on various charges over the month of June. In other areas of enforcement, our officers wrote 3,086 speeding citations, 623 hazardous moving citations and 584 seat belt citations.

Events and activities covered during June, 2011:

- Trooper Allen participated in two fundraisers for Special Olympics Nevada to include the "Over the Edge" event which included repelling off the 27th floor of the Grand Sierra Resort on June 3rd and the "Cops & Burgers" event on June 5th. Both highly visible events were covered by our local media and the hours spent at both venues were accomplished on volunteer time.
- Trooper Allen lectured at three driver's education classes in Reno and Sparks focused on traffic laws, accident causing contributing factors, alcohol awareness and distractions.
- Trooper Dan Lopez attended a safety awareness day at the Home Depot store in Carson City and handed out safety brochures and trinkets
- Trooper Allen attended a press conference with Nevada Department of Transportation (NDOT) personnel to preview the 3 ramp meters to become operational on Interstate 80 at the eastbound Keystone Avenue, Center St, and Wells Avenue on ramps in the Reno area.
- Trooper Allen attended a 4-day leadership and diversity class in Las Vegas with the Nevada Air National Guard
- Trooper Lopez and Trooper Allen spent several days with the local and national media updating them with the developments of the multiple fatality crash involving a commercial motor vehicle and an Amtrak passenger train in Churchill County.
- The Nevada Highway Patrol participated in a DUI checkpoint on Kietzke Lane that was sponsored by the Nevada Office of Traffic Safety and hosted by the Reno Police Department
- Trooper Allen gave a safety presentation to the Washoe-Safe Kids organization focused on distracted driving and provided statistics

FLIGHT OPERATIONS

The Northern Command Aircraft flew 2 missions during the month of June for a total of 4.7 flight hours. The aircraft has been out of service for maintenance since June 7. The following is a breakdown of activities.
