SAFESTAT REPORT

Overview

There were 69 crashes that occurred in September 2011. This is a decrease of 6.8% compared to last month's 74 crashes, and a decrease of 9.2% for crashes investigated in September 2010. Property crashes increased by 13% compared to August 2011. Injury crashes decreased by 34.6% as compared to August 2011. Central Command troopers investigated no fatal crashes during September 2011. There were no fatal accident investigations this month compared to 2 fatal accidents in August 2011 and 3 in September 2010. There were two crashes involving an impaired driver, which was an increase of 1 compared to last month and unchanged compared to last year. Of the 69 accidents, 19 or 27.5% involved commercial motor vehicles. Commercial drivers were found to be at fault in six or 31.5%, of these accidents. Nine of the commercial vehicle accidents occurred on Interstate 80.

Total enforcement activity for September 2011 was 2,304 cited violations. This was an increase of 217 violations or 10.4% as compared to August 2011. Compared to September of 2010, the command showed an increase of 332 violations or 16.8%. Speed violations increased by 3 or 0.3%, as compared to August 2011 and 23.5% compared to September 2010. Hazardous moving violations increased 8.2% from the prior month and 9.1%, compared to September 2010. Occupant restraint violations increased by 72.2% compared to August 2011 and decreased 11.6% compared to September 2010. There were 15 arrests of impaired drivers made in September 2011. Of those 15 arrests, 2 were made during an accident investigation. The total arrests for September 2011 showed a decrease of 28 persons arrested compared to August 2011 and a decrease of 21 compared to September 2010.

Commercial vehicle inspections increased by 50.7% or 260 inspections as compared to August 2011 and there were 122 more safety violations written in September 2011 than in August 2011. Commercial operations showed an increase of 43.8% or 28 more citations issued, compared to August 2011 and an increase of 3 citations or 3.4% compared to September 2010. Officers placed 34 vehicles and 31 drivers, "Out of Service", in September 2011. Vehicles placed out of service increased by 30.8% while drivers increased by 121.4% compared to August 2011. Vehicles placed out of service rose by 6.3% and drivers placed out of service increased by 40.9%, compared to September 2010. Traffic personnel conducted 339 commercial inspections during September 2011 where traffic personnel issued 91 safety violation citations and 244 safety violations. Additionally, 11 drivers where placed out of service by traffic personnel during September 2011.

Front office staff processed 16 fewer accidents for a decrease of 19.75% compared to August 2011. Arrest reports processed decreased by 20 or 30.77% compared to August 2011. Processed incident reports decreased by 22 compared to August 2011. The Communications Center radio transmissions increased by 0.11% compared to August 2011. Computer Aided Dispatch incidents also decreased by 33.35%. Telephone calls decreased by 16.61% as compared to August 2011.

Warrant office staff saw increases in warrants received, entered, validated, and saw an increase in warrants cleared compared to August 2011. Extraditions and transports decreased to four compared to last months seven.
