SAFESTAT REPORT

Overview

During the month of October 2011, we experienced a decrease in our overall traffic crashes when compared to the month of September 2011. Northern Command officers handled 265 crashes in the month of October. An overview of the crashes showed 179 were property damage, 82 were injury, and four were fatal. When compared to October of last year, fatal crashes remained the same. As compared to October of 2010, our regional commercial vehicle crashes decreased from 20, to 9 crashes. In our overall October 2011 totals, intoxicated drivers were responsible for 17 of our total crashes in the Northern Command.

The officers in our command arrested 81 intoxicated drivers this month. The average blood alcohol level of these intoxicated drivers was, .13%, well above the legal limit of .08% blood alcohol content. The average age of the intoxicated drivers was 35 years old. Our officers arrested an additional 73 people on various charges over the month of October. In other areas of enforcement, our officers wrote 2,981 speeding citations, 603 hazardous moving citations and 350 seat belt citations.

One speed enforcement mission was scheduled and flown this month. Due to a lack of manpower, only one ground unit was available. A total of 5 enforcement actions were taken before the aircraft was delivered to Carson City for maintenance.
