SAFESTAT REPORT

Overview

There were 105 crashes that occurred in November 2011. This is an increase of 22.1% compared to last month's 86 crashes, and a decrease of 36.7% for crashes investigated in November 2010. Property crashes decreased by 4.2% compared to October 2011. Injury crashes increased by 153.85% as compared to October 2011. Central Command troopers investigated three fatal crashes during November 2011. These crashes resulted in the deaths of three persons; one unrestrained driver, one unrestrained passenger, and one restrained passenger. There were three fatal accident investigations this month compared to one fatal accident in October 2011 and one in November 2010. There was one crash involving an impaired driver, which was one less compared to last month and unchanged compared to last year. Of the 105 accidents, 16 or15.2% involved commercial motor vehicles. Commercial drivers were found to be at fault in 10 or 62.5%, of these accidents. Eleven of the commercial vehicle accidents occurred on Interstate 80.

Total enforcement activity for November 2011 was 2292 cited violations. This was an increase of 307 violations or 15.3% as compared to October 2011. Compared to November of 2010, the command showed an increase of 1010 violations or 78.8%. Speed violations increased by 326 or 35.8%, as compared to October 2011 and 97.3% compared to November 2010. Hazardous moving violations decreased 4.3% from the prior month and decreased of 38.8%, compared to November 2010. Occupant restraint violations decreased by 5.4% compared to October 2011 and they increased by 86.4% compared to November 2010. There were 15 arrests of impaired drivers made in November 2011. Of those 15 arrests, one was made during an accident investigation. The total arrests for November 2011 showed a decrease of 15 persons arrested compared to October 2011 and a decrease of four compared to November 2010.

Commercial vehicle inspections increased by 19.6% or 104 inspections as compared to October 2011 and there were 47 more safety violations written in November 2011 than in October 2011. Commercial operations showed an increase of 28.9% or 13 more citations issued, compared to October 2011 and an increase of 9 citation or 18.4% compared to November 2010. Officers placed 17 vehicles and 17 drivers, "Out of Service", in November 2011. Vehicles placed out of service decreased by 26.1% while drivers increased by 13.3% compared to October 2011. Vehicles placed out of service fell by 5.6% and drivers placed out of service increased by 54.5%, compared to November 2010. Traffic personnel conducted 239 commercial inspections during November 2011 and issued 57 safety violation citations and 150 safety violations. Additionally, 6 drivers and 7 vehicles where placed out of service by traffic personnel during November 2011.

Front office staff processed 10 more accidents for an increase of 12.35% compared to October 2011. Arrest reports processed increased by 1 or 2.44% compared to October 2011. Processed incident reports increased by 2 compared to October 2011. The Communications Center radio transmissions increased by 7.9% compared to October 2011. Computer Aided Dispatch incidents also increased by 1.05%. Telephone calls decreased by 8.35% as compared to October 2011.

Warrant office staff saw increases in warrants received, entered, validated compared to October 2011. Warrants cleared decreased compared to October 2011. Extraditions and transports decreased by 75% compared to last month.
