# **SAFESTAT REPORT**

## **Overview**

During the month of December 2011, we experienced a slight incease in our overall traffic crashes when compared to the month of Novermber 2011. Northern Command officers handled 267 crashes in the month of December. An overview of the crashes showed 189 were property damage, 75 were injury, and three were fatal. When compared to December of last year, fatal crashes increased from one to three total. As compared to December of 2010, our regional commercial vehicle crashes increased from 20, to 22 crashes. In our overall December 2011 totals, intoxicated drivers were responsible for 16 of our total crashes in the Northern Command.

The officers in our command arrested 103 intoxicated drivers this month. The average blood alcohol level of these intoxicated drivers was, .19%, over twice the legal limit of .08% blood alcohol content. The average age of the intoxicated drivers was 37 years old. Our officers arrested an additional 68 people on various charges over the month of December. In other areas of enforcement, our officers wrote 3,361 speeding citations, 807 hazardous moving citations and 504 seat belt citations.
