SAFESTAT REPORT

Overview

There were 63 crashes that occurred in February 2012. This is a decrease of 14.9% compared to last month's 74 crashes, and a decrease of 1.49% for crashes investigated in February 2011. Property crashes decreased by 15.1% compared to January 2012. Injury crashes decreased by 5.6% as compared to January 2012. There was one fatal accident investigation this month compared to three fatal accidents in January 2012 and zero in February 2011. In this crash there was one person that sustained fatal injuries; one restrained driver. There were five crashes involving impaired drivers, which was five more compared to last month and two more compared to last year. Of the 63 accidents, 13 or 20.6% involved commercial motor vehicles. Commercial drivers were found to be at fault in nine or 69.3%, of these accidents. Seven of the commercial vehicle accidents occurred on Interstate 80.

Total enforcement activity for February 2012 was 1828 cited violations. This was an increase of 79 violations or 4.5% as compared to January 2012. Compared to February of 2011, the command showed a decrease of 435 violations or 19.2%. Speed violations decreased by 1 or 0.1%, as compared to January 2012 and decreased 25% compared to February 2011. Hazardous moving violations increased 14.9% from the prior month and decreased of 29.8%, compared to February 2011. Occupant restraint violations increased by 52.1% compared to January 2012; and they declined by 47.3% compared to February 2011. There were 25 arrests of impaired drivers made in February 2012. Of those 25 arrests, five were from accident investigations. The total arrests for February 2012 showed an increase of seven persons arrested compared to January 2012 and a decrease of nine compared to February 2011.

Commercial vehicle inspections increased by 12.4% or 74 inspections as compared to January 2012 and there were 108 more safety violations written in February 2012 than in January 2012. Commercial operations showed 17 more citations issued, compared to January 2012 and a decrease of 46 citation or 46.5% compared to February 2011. Officers placed 27 vehicles and 20 drivers, "Out of Service", in February 2012. Vehicles placed out of service increased by 22.7% while drivers increased by 5.3% compared to January 2012. Vehicles placed out of service fell by 10% and drivers placed out of service decreased by 20%, compared to February 2011. Traffic personnel conducted 228 commercial inspections during February 2012 and issued 45 safety violation citations and 157 safety repair order violations. Additionally, 10 drivers and 9 vehicles where placed out of service by traffic personnel during February 2012.

Front office staff processed 39 less accident for a decrease of 44.8% compared to January 2012. Arrest reports processed increased by 5 or 12.5% compared to January 2012. Processed incident reports increased by 10 compared to January 2012. The Communications Center radio transmissions decreased by 0.23% compared to January 2012. Computer Aided Dispatch incidents also increased by 21.19%. Telephone calls decreased by 71.46% as compared to January 2012 (There was a recorder failure that counts the calls).

Warrant office staff saw increases in warrants received and validated compared to January 2012. Warrants cleared and entered decreased compared to January 2012. Extraditions and transports decreased compared to last month.
