SAFESTAT REPORT

Overview

There were 95 crashes that occurred in March 2012. This is an increase of 50.8% compared to last month's 63 crashes, and an increase of 110.5% for crashes investigated in March 2011. Property crashes increased by 40% compared to February 2012. Injury crashes increased by 70.6% as compared to February 2012. There were three fatal accident investigations this month compared to one fatal accident in February 2012 and one in March 2011. In these crashes there were three persons that sustained fatal injuries; two restrained drivers and one restrained passenger. There were four crashes involving impaired drivers, which was one less when compared to last month and four more compared to last year. Of the 95 accidents, 15 or 15.8% involved commercial motor vehicles. Commercial drivers were found to be at fault in ten or 71.3%, of these accidents. Eight of the commercial vehicle accidents occurred on Interstate 80.

Total enforcement activity for March 2012 was 2028 cited violations. This was an increase of 200 violations or 10.9% as compared to February 2012. Compared to March of 2011, the command showed a decrease of 110 violations or 5.1%. Speed violations increased by 102 or 13.6%, as compared to February 2012 and decreased 22.4% compared to March 2011. Hazardous moving violations increased 25.9% from the prior month and decreased of 13.0%, compared to March 2011. Occupant restraint violations increased by 59.3% compared to February 2012; and they declined by 3.4% compared to March 2011. There were nine arrests of impaired drivers made in March 2012. Of those nine arrests, four were from accident investigations. The total arrests for March 2012 showed an increase of one person arrested compared to February 2012 and an increase of two compared to March 2011.

Commercial vehicle inspections decreased by 12.8% or 86 inspections as compared to February 2012 and there were 101 fewer safety violations written in March 2012 than in February 2012. Commercial operations showed 41 fewer citations issued, compared to February 2012 and a decrease of 46 citation or 56.8% compared to March 2011. Officers placed 12 vehicles and 16 drivers, "Out of Service", in March 2012. Vehicles placed out of service decreased by 55.6% while drivers decreased by 20% compared to February 2012. Vehicles placed out of service fell by 50% and drivers placed out of service decreased by 5.9%, compared to March 2011. Traffic personnel conducted 239 commercial inspections during March 2012 and issued 49 safety violation citations and 159 safety repair order violations. Additionally, 11 drivers and 7 vehicles where placed out of service by traffic personnel during March 2012.

Front office staff processed 49 more accident for an increase of 102% compared to February 2012. Arrest reports processed increased by 20 or 44.4% compared to February 2012. Processed incident reports decreased by 3 compared to February 2012. The Communications Center radio transmissions increased by 8.85% compared to February 2012. Computer Aided Dispatch incidents also increased by 2.62%. Telephone calls were not counted or compared to February 2012 (There was a recorder failure that counts the calls, it has been sent for repairs).

Warrant office staff saw increases in warrants entered compared to February 2012. Warrants cleared, validated and received decreased compared to February 2012. Extraditions and transports increased compared to last month.
