Overview

Narrative

In the month of March 2012, we experienced a decrease in our overall traffic crashes when compared to the month of February. Northern Command officers handled 248 crashes in the month of March. An overview of the crashes showed 179 crashes were property damage and 68 were classified as injury crashes and one crash was fatal. As compared to March of 2011, our regional commercial vehicle crashes decreased to a total of 20. In our overall March 2012 totals, intoxicated drivers were responsible for 8 DUI crashes in the Northern Command.

The officers in our command arrested 91 intoxicated drivers this month. The average blood alcohol level of these intoxicated drivers was, .18%, over twice the legal limit of .08% blood alcohol content. The average age of the intoxicated drivers was 33 years old. Our officers arrested an additional 96 people on various charges over the month of March. In other areas of enforcement, our officers wrote 3,341 speeding citations, 1,251 hazardous moving citations and 498 seat belt citations.
