SAFESTAT REPORT

Overview

There were 70 crashes that occurred in May 2012. This is an increase of 6.1% compared to last month's 66 crashes, and a decrease of 23.9% for crashes investigated in May 2011. Property crashes were unchanged compared to April 2012. Injury crashes increased by 29.4% as compared to April 2012. There were two fatal accident investigations this month compared to three fatal accidents in April 2012 and three in May 2011. In these crashes there were two persons that sustained fatal injuries; one restrained driver and one un-restrained driver. There were eight crashes involving an impaired driver, which was seven more when compared to last month and five more compared to last year. Of the 70 accidents, 12 or 17.1% involved commercial motor vehicles. Commercial drivers were found to be at fault in six or 50%, of these accidents. Four of the commercial vehicle accidents occurred on Interstate 80.

Total enforcement activity for May 2012 was 2522 cited violations. This was an increase of 221 violations or 9.6% as compared to April 2012. Compared to May of 2011, the command showed an increase of 248 violations or 10.9%. Speed violations increased by 6 or 0.5%, as compared to April 2012 and decreased 2.5% compared to May 2011. Hazardous moving violations increased 4% from the prior month and decreased of 21.1%, compared to May 2011. Occupant restraint violations increased by 23.3% compared to April 2012; and they fell by 10.8% compared to may 2011. There were 27 arrests of impaired drivers made in May 2012. Of those 27 arrests, eight were from an accident investigation. The total arrests for May 2012 showed an increase of 7 persons arrested compared to April 2012 and an increase of 14 compared to May 2011.

Commercial vehicle inspections increased by 18.3% or 95 inspections as compared to April 2012 and there were 86 more safety violations written in May 2012 than in April 2012. Commercial operations showed three fewer citations issued, compared to April 2012 and a decrease of 29 citations or 33.7% compared to May 2011. Officers placed 27 vehicles and 16 drivers, "Out of Service", in May 2012. Vehicles placed out of service increased by 145% while drivers placed "Out of Service" were unchanged compared to April 2012. Vehicles placed out of service fell by 6.9% and drivers placed out of service fell by 23.8% compared to May 2011. Traffic personnel conducted 287 commercial inspections during May 2012 and issued 66 safety violation citations and 209 safety repair order violations. Additionally, 16 drivers and 10 vehicles were placed out of service by traffic personnel during May 2012. During the month of May there was annual recertification training classes attended by multiple traffic and commercial personnel.

Front office staff processed three more accident reports for an increase of 5.26% compared to April 2012. Arrest reports processed increased by 11 or 26.19% compared to April 2012. Processed incident reports increased by two compared to April 2012. The Communications Center radio transmissions increased by 9.74% compared to April 2012. Computer Aided Dispatch incidents also increased by 15.06%. Telephone calls were not counted or compared to April 2012 (The recorder equipment that counts the calls is still out for repairs).

Warrant office staff saw increases in warrants validated compared to April 2012. Warrants received, entered and cleared decreased compared to April 2012. Extraditions and transports increased compared to last month.
