Northern Command West began its busy special events season this month with the annual Hot August Nights event August 9-12, 2012. We utilized additional staff to work in conjunction with the Washoe County Sheriff's Office, Reno Police Department, and the Spark Police Department to provide a safe environment for the motoring public. This event was quickly followed by the annual Burning Man event which began on August 25, 2012. We contracted with the event's organizers to provide additional staff on the roads into and out of the event. Lastly, the annual Rib Cook Off began on August 29, 2012. NHP did not provide any additional staff for this event as no traffic concerns were identified.

In support of the Strategic Highway Safety Plan, all commanders in both the Northern Command West and East are participating on committees in the five critical emphasis areas: impaired driving, seatbelts, pedestrians, lane departures, and intersections.

This month we experienced a 21.1% increase in our overall traffic crashes when compared to the month of July. Northern Command West officers handled 350 crashes in August. An overview of the crashes showed 237 were property damage, 109 were classified as injury crashes, and four were classified as fatal crashes. As compared to July of 2011, we experienced a 120% increase in our regional commercial vehicle crashes at 33 for the month. In our overall August 2012 totals, intoxicated drivers were responsible for 19 crashes in Northern Command West.

The officers in our command arrested 82 intoxicated drivers this month. The average blood alcohol level of those intoxicated drivers was 0.16%, twice the legal limit of .08% blood alcohol content. The average age of the intoxicated driver was 36 years old. Our officers arrested an additional 106 people on various charges over the month of August. In other areas of enforcement, our officers wrote 2,683 speeding citations, 1,115 hazardous moving citations, and 324 seat belt citations.
