Overview

Northern Command West concluded its busy special events season this month with the Hot Air Balloon Races, Reno Air Races, Street Vibrations, and the Candy Dance. We utilized additional staff on all events and worked in conjunction with the Washoe County Sheriff's Office, Reno Police Department, and the Sparks Police Department. Due to the violence during last year's Street Vibrations event, we cancelled the days off for all personnel and saturated the Reno/Sparks area to provide high police visibility and a safe environment for the motoring public. In addition, President Obama and Governor Romney both visited our area for campaign activities.

In continued support of the Strategic Highway Safety Plan, all commanders in both the Northern Command West and East participated on committees in the five critical emphasis areas: impaired driving, seatbelts, pedestrians, lane departures, and intersections.

This month we experienced a 57.8% increase in our overall traffic crashes when compared to the month of August. Northern Command West officers handled 322 crashes in September. An overview of the crashes showed 221 were property damage, 99 were classified as injury crashes, and two were classified as fatal crashes. As compared to September of 2011, we experienced a 50% decrease in our regional commercial vehicle crashes at 18 for the month. In our overall September 2012 totals, intoxicated drivers were responsible for 18 crashes in Northern Command West.

The officers in our command arrested 104 intoxicated drivers this month. The average blood alcohol level of those intoxicated drivers was 0.16%, twice the legal limit of 0.08% blood alcohol content. The average age of the intoxicated driver was 36 years old. Our officers arrested an additional 207 people on various charges over the month of September. In other areas of enforcement, our officers wrote 2,726 speed citations, 1,204 hazardous moving citations, and 311 seatbelt citations.
