Southern Command personnel handled 1,066 crashes in November 2012. Of these, 727 were property damage, 334 were injury, and 5 were fatal. The total crashes decreased by 12.8% compared to last year. When compared to last year, fatalities increased 150.00%. 46 of these crashes involved commercial vehicles; 13 resulted in injuries, 33 were property damage, and 0 resulted in fatality. Crashes involving commercial vehicles represented 4.3% of the total crashes handled by the Southern Command. Impaired drivers were responsible for 1.5% of all crashes in the Southern Command.

The Southern Command is driven to provide this community with a professional and effective law enforcement presence. The Southern Command extends a thank you to all those who assisted us in gaining success in our law enforcement services this past month.
