# **SAFESTAT REPORT**

# **Overview**

This month the Northern Command West participated in 6 special enforcement assignments. In addition, the area completed a total of 9,618 public contacts. One employee spent 11 days in South Korea supporting the Special Olympics. In addition, our region donated 91 hours of training in support of the Basic Acadamy.

In continued support of the Strategic Highway Safety Plan, all commanders in both the Northern Command West and East participated in committees in the five critical emphasis areas: impaired driving, seatbelts, pedestrians, lane departures, and intersections.

This month we experienced a 40% decrease in overall traffic crashes when compared to the month of December 2012. This was mostly attributed to the severe snow storms that plagued our area last month. Northern Command West officers handled 288 crashes in January. An overview of the crashes showed 212 were property damage, 75 were classified as injury crashes, and one was classified as a fatal crash. As compared to January of 2012, we experienced a 55.3% decrease in our regional commercial vehicle crashes at 17 for the month. In our overall January 2013 totals, intoxicated drivers were responsible for 8 crashes in the Northern Command West.

The officers in our command arrested 57 intoxicated drivers this month. The average blood alcohol level of those intoxicated drivers was 0.14%, nearly twice the legal limit of 0.08% blood alcohol content. The average age of the intoxicated drivers was 36 years old. Our officers arrested an additional 187 people on various charges over the month of January. In other areas of enforcement, our officers wrote 2,133 speed citations, 837 hazardous moving citations, and 248 seatbelt citations.
