Overview

Southern Command personnel handled 1,082 crashes in January 2013. Of these, 815 were property damage, 263 were injury, and 4 were fatal. The total crashes increased by 8.0% compared to last year. When compared to last year, fatalities decreased 33.3%. 50 of these crashes involved commercial vehicles; 10 resulted in injuries, 40 were property damage, and 0 resulted in fatality. Crashes involving commercial vehicles represented 4.6% of the total crashes handled by the Southern Command. Impaired drivers were responsible for 2.0% of all crashes in the Southern Command.

The Southern Command is driven to provide this community with a professional and effective law enforcement presence. The Southern Command extends a thank you to all those who assisted us in gaining success in our law enforcement services this past month.

- ✿ Percentage of persons killed *without* seatbelts to total persons killed 0%
- ✿ Percentage of commercial vehicle crashes to total crashes 4.6 %
- ✿ Total crashes increased 8.0 % compared to last year.
- ✿ Commercial vehicle crashes increased 108.3 % from last year.
- ✿ Fatality crashes decreased 33.3 % compared to last year.
